Item 3. Shareholders.

1. As of December 31, 2011, Synovus Bank (Columbus, Georgia), a Georgia/US banking corporation, held through its wholly-owned trust company subsidiary, Synovus Trust Company, in various fiduciary capacities, a total of 47,035,079 shares or 5.99%, of Synovus Common Stock as to which it possessed sole or shared voting or investment power, and as to all of which shares it disclaims beneficial ownership.
2. FMR LLC (Boston, Massachusetts), a Delaware corporation, and its direct and indirect subsidiaries, owned 78,429,661 shares, or 9.99%, of Synovus Common Stock as to which it possessed sole or shared voting or investment power during the fiscal year. This information is based upon information included in a Schedule 13G filed on February 14, 2011 by FMR LLC.

FMR LLC filed an Amendment No. 1 to such Schedule 13G on January 10, 2012, however, indicating that as of December 31, 2011, FMR LLC and its direct and indirect subsidiaries owned 25,045,327, or 3.189%, of Synovus Common Stock as to which it possessed sole or shared voting or investment power.


