



The EPSP owns less than 5% of the Holding Company Stock. If the shares owned by the EPSP are added to the Trustees percentages in column (4)(a), then the corresponding figures would be 2.49% for Mr. Hayes, 2.14% for Mr. Haney and 1.74% for Mr. Porterfield.
