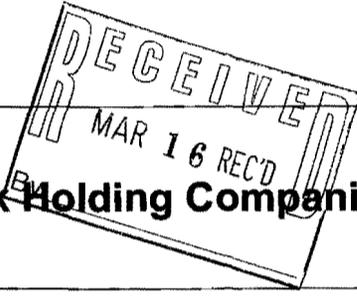

# Annual Report of Bank Holding Companies—FR Y-6
