



On October 1, 2004, MidSouth Bancorp, Inc. paid \$10.8 million in cash and issued 461,329 (369,063 pre split) shares of its stock valued at \$11.4 million to acquire Lamar Bancshares, Inc. (100% ownership) Named changed 12/01/06 from Lamar Bank to MidSouth Bank. MidSouth Bank in Texas merged with MidSouth Bank, N.A. on March 21, 2008.
- MidSouth Bancorp, Inc. owns 100% of Financial Services of the South, Inc.
- MidSouth Bancorp, Inc. acquired 7,000 Capital Securities from MidSouth Statutory Trust I on February 22, 2001. 100% ownership.
- MidSouth Bancorp, Inc. acquired 8,000 Capital Securities from MidSouth Statutory Trust II on September 20, 2004. 100% ownership.
- Lafayette Liquidators, Inc. 100% owned by MidSouth Bancorp, Inc. is a non active subsidiary.
- At the close of business on 12/28/12, MidSouth Bancorp, Inc. acquired PSB Financial Corporation and all subsidiaries. 100% ownership.
