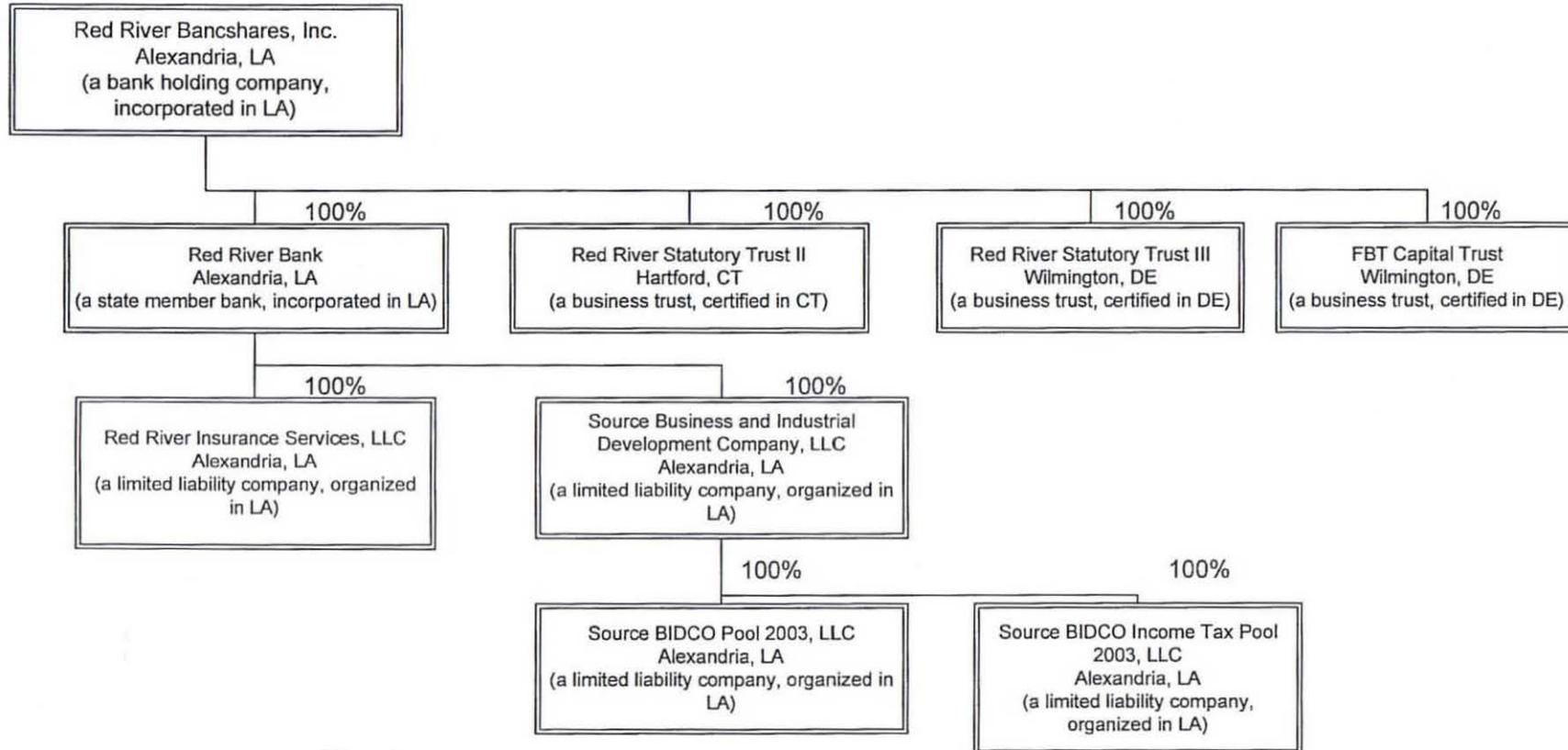
The BHC a privately-held company and thus is not registered with the Securities and Exchange Commission, and therefore does not prepare an annual report on Form 10-K.
